12 **Item No.1. Appeal Authority Alternates – Resolution 020-2018:** The Providence City Council will consider for
13 adoption a resolution appointing alternates to the Providence Appeal Authority.

15 Mayor Drew explained the Appeal Authority consists of 3 members, two being residents of Providence City, one a
16 professional that may or may not be a resident of Providence City.

17 Mayor drew explained there are times members cannot attend and it is good to have a pool of about 5 candidates
18 to attend in their place.

19 Mayor Drew stated on average there are about 2 appeals hearings a year.

20 Mayor Drew introduced Edward Banda.

21 Edward Banda bought his first home in Cache Valley in 2004. He has been a resident of Providence City for the
22 past 4 years. He has been a construction superintendent for the past 30 years. He has been semi-retired for the
23 past 1 ½ years.

24 K Allen asked how many members are on the committee. S Bankhead explained there are 3.

25 K Allen Q: What is your vision of what this position is and what are your responsibilities?

26 E Banda A: My vision and concept is a developer will get an idea of building his dream home in this area. He will
27 submit a package to the city for plan check. It will be checked and then go back for corrections. If it gets denied
28 the plans will go to a review board and that panel will decide what will happen.

29 K Allen explained he liked the fact that E Banda has been involved in certain stages of this process as a supervisor
30 before.

31 R Sneddon Q: How do you feel about helping people who are angry?

32 E Banda A: I worked in an area that it was very common to deal with people that were under stress and timelines.

33 Most of which were doctors and surgeons. I volunteer a lot to help meet deadlines.

34 I am fair and unbiased.

36 The council vote is advisory and it is Mayor Drew's recommendation to appoint Edward Banda as an alternate on
37 the planning authority.
