**Item No. 1:** The Providence City Planning Commission will discuss amending Providence City Code Title 10 Chapter 5 Overlay Zones addressing non-developable sensitive area, potentially developable sensitive area, hazard wildfire zones, and engineering geotechnical report.

**Item No. 2:** The Providence City Planning Commission will discuss amending Providence City Code Title 10 Zoning Regulations Chapter 1 General Provisions.

**Item No. 3:** The Providence City Planning Commission will discuss amending Providence City Code Title 11 Subdivision Regulations Chapter 2 Administration and Enforcement and Chapter 5 Public Improvements regarding exceptions to the Title; and Chapter 3 regarding sidewalk requirements.

**Item No. 4:** The Providence City Planning Commission will discuss amending Providence City Code 11-4-3:J. Sidewalks, and the Downtown Street Cross-Sections.

**Item No. 5:** The Providence City Planning Commission will discuss amending Providence City Code 10-8- Cell tower landscaping requirements.

**Item No. 6:** The Providence City Planning Commission will discuss amending Providence City Code Title 11-5-2 by adding the following to the minimum improvement requirements: All curb, gutter and all utility trenches that lay inside the roadway.
