3 AN ORDINANCE AMENDING PROVIDENCE CITY CODE TITLE 1 ADMINISTRATION, CHAPTER 6
4 MAYOR AND CITY COUNCIL BY CHANGING THE DAY OF REGULAR CITY COUNCIL MEETINGS.

6 WHEREAS UCA § 10-3-701 states, “. . . except as otherwise specifically provided, the governing
7 body of each municipality shall exercise its legislative power through ordinances.”; and

8
9 WHEREAS PCC 1-6-7:A. states,

10 A. Regular Meetings:

- 11 1. The City Council may hold two (2) regular meetings which shall be held on the second or
- 12 fourth Tuesday of each month at the Providence City Office.
- 13 2. At a minimum, the City Council shall hold one (1) meeting each month.
- 14 3. Meetings shall begin at 6:00 P.M.
- 15 4. The City Council may by vote provide for a different time and place for holding a
- 16 meeting, if a majority of those voting deem it to be in the best interest of the citizens.

18 WHEREAS Providence City Council and the Cache County Council hold their meetings on the
19 same evenings; and

20
21 WHEREAS Providence council members would like to attend Cache County council meetings,
22 without missing a city council meeting; and

24 ~~WHEREAS the Providence Planning Commission currently holds their regular meetings on the~~
25 ~~second and fourth Wednesday of the month; and~~

27 ~~WHEREAS Providence council members suggested moving planning commission to Tuesday and~~
28 ~~the council meetings would allow applicants to attend planning commission and then city~~
29 ~~council during the same week, rather than a 13-day time lapse between the two meetings.~~

31 ~~WHEREAS Providence council members suggested Mayor Drew requests the Council consider~~
32 ~~amending the City Code to read as follows:~~

- 33 1. The City Council may hold two (2) regular meetings which shall be held on the ~~second~~
- 34 ~~first~~ or ~~fourth~~ ~~third~~ Tuesday ~~Wednesday~~ of each month at the Providence City Office.

36 THEREFORE be it ordained by the Providence City Council:

- 37 • The attached code amendment shall be approved and the city code update to reflect
- 38 the change.
- 39 • This ordinance shall become effective immediately upon passage and posting or 30 days
- 40 after final passage, whichever is closer to the date of final passage.
