Public Hearing 6:15: The Providence City Council will hold a public hearing to receive public comment on adjusting the 2011 Budget for the following Funds: General, Capital Project, Water, Sewer, and Storm Water.

Business Items:

Item No. 1. Discussion. The Providence City Council will discuss the improvements and funding for the cul-de-sac located at approximately 390 West 100 South.

Item No. 2. Resolution No. 10-035. The Providence City Council will consider for adoption a resolution adjusting the 2011 Budget for the following Funds: General, Capital Project, Water, Sewer, and Storm Water.

Item No.3. Discussion. The Providence City Council will discuss the name change from Spring Creek Parkway to Gateway Drive from the new intersection of Gateway Drive and Spring Creek Parkway to 100 North.

Item No.4 Ordinance No. 010-2010. The Providence City Council will reconsider the adoption Ordinance No. 010-2010 an ordinance amending Title 6 Chapter 2 by adding regulations for parking in front of mailboxes.


Executive Session:
