16 Item No. 1. 2019 Projects: The HPC will discuss options, including but not limited to restoring and
17 relocating an old post office building and a history for a portion of the Utah-Idaho Central Railway that
18 was located in Providence City.

- 19 • W Bitters reported he has spoken with the Leonhardt's and they are in favor of relocating the
20 building if it is agreeable on both sides. The family would like to be assured that if the old rock
21 church gets sold that the city will take on the responsibility to move the building to a safe
22 location.
- 23 • G Trowbridge feels this request by the Leonhardt's is fair.
- 24 • H Christenson read the memorandum of understanding and will forward to W Bitters.
- 25 • W Bitters will move forward in getting the commitment from the family.
- 26 • H Christenson explained that he spoke with Rebecca Anderson about the Utah-Idaho Central
27 Railway History project. He stated she will send the outline out to students for research.
- 28 • H Christenson will put together an outline of the project and send to R Anderson.

 - 30 ○ Who built it/what the cost of the tracks were
 - 31 ○ Location of the line throughout Providence and the Valley
 - 32 ○ Economic impact
 - 33 ○ Who used it/how it was used
 - 34 ○ Relationship to other railways
 - 35 ○ Why it was built
 - 36 ○ Established/discontinued
 - 37 ○ Description of what it looked like/size
 - 38 ○ Photos
- 39 • H Christenson will speak with S Bankhead to determine if there are funds available to give to the
40 student who completes the history of the railway.
- 41 • H Christenson suggested asking Providence Pioneer Heritage, Inc to contribute the funds if they
42 aren't available through the city.
- 43 • W Bitters would like to see the history of the Utah-Idaho Railway on the city website.
