Electronic Meetings:

Members of the Public Body may be attending the meeting electronically (Providence City Code 1-6-7:E).

Public meetings held electronically will be in accordance with Utah Code Ann. §§ 52-4-207 et. seq., Open and Public Meetings Act. The Providence City Office Building, 164 N. Gateway Dr. is the anchor location; unless otherwise determined by the meeting chair, in accordance with UCA 52-4-207(4), an electronic meeting will be held without an anchor location.
