26 Forgotten Fruit Way plaques, as well as the funding for them. It is estimated that each will cost
27 \$3,500.

29 • Howard Christenson called item 1 and provided members of the Commission a handout of the two new
30 proposed plaque descriptions with accompanying pictures. Parties discussed which plaque should be
31 placed first and came to the consensus that the farming plaque should be the one to work on and place
32 first; with the fruit way plaque to be completed when they have the funds to do so.
- 33 • Parties discussed where the new farming plaque should go. Parties agreed to place the farming plaque
34 within Hampshire Park. Wes Bitters motioned to use the remaining funds for the creation and placing of
35 the farming plaque. Gail Trowbridge seconded his motion.
- 36 • Parties discussed their current funds. Staff indicated that additional funds would be available in July of
37 2023 to complete their fruit way plaque.
- 38 • Parties discussed the current draft for the wording of the plaques and Gordon Allred suggested a few
39 edits. Parties agreed to the edits and clarified the motion.
