23 **Item No. 1:** The Historic Preservation Commission will discuss and may take action on moving forward with
24 the cost and construction of a new historical marker.

26 • Howard Christenson called item one and discussed with the Commission that he had received a quote
27 for the new farming marker. Indicated to the Commission that the quote came in at \$4,000.
28 • Parties discussed previous plaque prices and why the price has gone up so much. Howard responded that
29 additional surcharges have been added and shipping cost has increased. Howard commented that he is
30 trying to contact Baer Welding about the pedestal and that the cost of that ranges around \$900.
31 • Commission discussed their options and wondered if they should wait for prices to go down or look to
32 other companies to see what they can provide and for how much.
33 • Parties discussed the price of the previous plaques and pedestals and how significant the price increase is
34 with this new farming marker.
35 • Brent Speth, Providence City Council Member, indicated that he would talk to staff about available
36 funds and if the City Council can help somehow.
37 • Parties discussed the current plaques throughout the city and trying to get something in the city
38 newsletter informing the citizens of the new plaques and their locations.
39 • Brent Speth affirmed that we could contact staff and talk with the City Council about the funds. Howard
40 indicated that he would continue to contact Baer Welding to get an exact price on the pedestal.

42 **Item No. 2:** The Historic Preservation Commission will discuss the status and continued process of obtaining
43 the Ev Thorpe painting from the Astle family.

45 • Howard Christenson called item 2 and asked Gordon Allred to give an update on the painting.

- 46 • Gordon Allred indicated that a meeting had been set up for next week with the family, himself, and the
47 City Manager to work out the details of the agreement.
- 48 • Parties discussed for those present the painting by Ev Thrope, its current location, and their ongoing
49 attempts to get it loaned to the city and displayed here in the Council room. Commission indicated they
50 are trying to work out the details of the loan agreement and insurance with the Astle family who
51 currently own the painting.
- 52 • Gordon Allred commented on the structure of the painting and its overall durability.
- 53 • Parties discussed the history of the painting and Ev Thorpe’s etchings that will also be on display here in
54 the Council room once we obtain the painting.
- 55 • Howard Christenson commented on Mr. Wooten’s presence and indicated to the Commission his
56 interest in serving.
- 57 • Mr. Wooten introduced himself and commented that he would like to be of help whenever he can
58 whether he becomes and alternate member or not.


